
On behalf of the Canadian Institutes of Health Research (CIHR), I am pleased to announce that approximately **200 Canada Graduate Scholarships - Master's Awards (CGSMA)** will be offered for the February 2009 competition to students who are pursuing a Master's degree in a health-related field in Canada. Awards have a maximum term of one year and are valued at \$17,500 per annum. Information regarding the program is included with this letter and will also be available on the CIHR Website.

The process by which CIHR is administering the CGSMA program is to provide each university in Canada, as determined by membership in the Association of Universities and Colleges of Canada, a quota of applications. This means that each university will be permitted to submit a maximum number of applications to the competition, subject to change each year. As such, an internal review process may have to occur at your university to determine the best applications to put forward to CIHR. Applications received at CIHR will be reviewed for eligibility and then forwarded to the most appropriate peer review panel dedicated to this program. The guide to the scoring of applications used by CIHR review panel members is enclosed and may be of use in the internal review process at your institution.

University of Manitoba has been provided with an application quota of 7. The deadline for applications at CIHR is February 1, 2009.

Additional Information for University Administrators on the Canada Graduate Scholarships Master's Awards (CGSMA) Program

Application Quota

Each Canadian academic institution, as determined by membership within the Association of Universities and Colleges of Canada (AUCC), will be provided with a quota of applications unless the institution is affiliated to another major institution. The quota indicates the maximum number of applications that a University is permitted to submit to this program. Therefore, an internal review process may have to occur at your institution to determine the best applications to put forward to CIHR. Applications received at CIHR will be reviewed for eligibility and then forwarded to the most appropriate peer review panel dedicated to this program. Please note that the quota of applications is subject to change each year.

For your information, the quota allocation was based on a combination of undergraduate and Master's student enrollment, as well as level of CIHR funding at your institution and its affiliate institutions (i.e., universities, teaching hospitals, research centres, etc) during 2007-2008. As the funding at your affiliates was taken into consideration when determining your application quota, internal competitions that occur at your institution to determine which applications will put forward to CIHR should be open to eligible candidates from your affiliated Institutions.

Location of Tenure

These awards must be held at a Canadian institution, but not necessarily the one at which the candidate was registered during the Fall semester prior to the CIHR deadline for application for this program. Your institution may forward applications for awards to be held both outside of and within your institution. CIHR expects that applications for awards to be held outside of your institution will be given equal consideration. These will be counted as part of the application quota.

Pre-selection Process at Universities

CIHR requires a brief description of the pre-selection process used at your institution (no more than one page) to be forwarded to CIHR along with the applications. The description should include information on the criteria used to make the selection, the type of people and committees involved in making the selection, the total number of applications received, measures taken to ensure that applications to be held outside of your university were given equal consideration, etc. The guide to the scoring of applications used by CIHR review panel members is enclosed. This may be of use to the internal review process at your institution.

Deadline for Applications

The deadline for all applications to this program is February 1, 2009. There are two types of candidates: those that apply through a Canadian institution and those that apply to CIHR directly. Candidates should apply through your institution if they are registered in any program, in any level course, or in any other capacity at your institution or an affiliate university during the Fall semester prior to the CIHR deadline. All other applications should be made to CIHR directly.

Other funding opportunities

Several CIHR partners or Institutes/Branches may offer other funding opportunities for students at the Master's level. These other funding opportunities will be posted on the CIHR website (<http://www.cihr-irsc.gc.ca/e/780.html>) as a Priority Announcements (PA). To be considered for these other funding opportunities, candidates should indicate the name of the PA on page 3 of their Training Module.

CIHR expects that applications requesting to also be considered for other funding opportunities be given equal consideration during the institution's internal review process. These applications will still be counted as one application quota.

Stipends

Awardees will receive an annual stipend of \$17,500. Offers of awards will be sent to successful candidates, it will be their responsibility to notify the institution where they will be attending that they were successful in receiving an award.

Effective Date

Results from the competition will be announced in early July. Awards must be taken up within six months of the date of offer and must start September 1 or January 1 following the offer of award. These start dates are based on the profiling of the funds and CIHR's fiscal year. We realize that not all students would start their programs in this time frame but almost all students would have the opportunity for an award at some point during a Master's program and should time their applications accordingly.

The package of applications with a covering letter from the Dean of Graduate Studies, or other appropriate institutional official, describing the pre-selection process and indicating the total number of applications received must be sent to CIHR by February 1, 2009 to the following address:

Description

The Canada Graduate Scholarships Master's Awards administered by CIHR are intended to provide special recognition and support to students who are pursuing a Master's degree in a health related field in Canada. These candidates are expected to have an exceptionally high potential for future research achievement and productivity.

Funds Available

CIHR's contribution to the amount available for this initiative is subject to availability of funds voted annually to CIHR by parliamentary appropriations, and the conditions that may be attached to them.

Applications are invited in all areas of health research.

For this competition, applications will be accepted in all areas of health research.

The maximum amount awarded for a single award is \$17,500 for up to one year:

- Trainee stipend: \$17,500 per annum.
- This award is non-renewable.

Funding Opportunities in Specific Research Areas

Funds are available for this competition to support Master's Award applications in specific research areas:

- Master's Award: Spring 2009 Priority Announcement (Specific Research Areas)

Objectives

The objective of the Government of Canada's Canada Graduate Scholarships program is to help ensure a reliable supply of highly qualified personnel to meet the needs of Canada's knowledge economy.

Eligibility

Eligibility criteria for all CIHR research funding programs apply. The business office of the institution of an eligible Nominated Principal Applicant generally administers CIHR funds. Please refer to the Eligibility Requirements for CIHR Grants and Awards regarding the eligibility requirements for individuals and institutions.

Specific to CIHR training awards, please refer to the General Guidelines for Training Programs.

Specific Eligibility Requirements

The award for which support is being sought should be under the supervision of a researcher who holds research funds obtained through a recognized competitive peer review process. These awards must be held at a Canadian institution.

Eligibility to Apply for an Award

To be considered eligible to apply for support, a candidate must:

- be a Canadian citizen or a permanent resident;
- at the time of the CIHR deadline for application (February 1st):
 - have completed or be in the last year of a Bachelor's degree; or
 - have been registered for no more than ten months as a full-time student in a Master's program; or
 - have been registered for no more than ten months as a full-time PhD student and were admitted to the PhD program directly from the Bachelor's degree.
- be applying for support to pursue their **first** graduate degree (i.e., Master's or PhD). All previous studies at the graduate level, regardless of discipline, either course-based or research-based, will be included in determining eligibility; and
- not have already held an award from SSHRC, NSERC, CIHR or any other federal source to

undertake and/or complete a Master's or PhD degree.

Persons with a health professional degree who seek support for Master's or PhD research training may be eligible to apply to this program, but should also consult the guidelines for the CIHR Fellowship award program. Those eligible for both have the option of applying to either program but not to both in the same year (i.e., September through August). Please note that a person holding a health professional degree would receive a higher stipend only through the CIHR Fellowship award program.

Eligibility to Hold an Award

To be considered eligible to hold support, a candidate must:

- be registered full-time in the first or second year of a Master's or PhD program in which research is a major component (awards will not take effect until after proof of registration is received); and
- not have already held, or hold, an award from SSHRC, NSERC, CIHR or any other federal source to undertake and/or complete a Master's or PhD degree.

Awards must be taken up within six months of the date of offer and must start September 1 or January 1 following the offer of award.

Guidelines

This funding opportunity will follow the [General Guidelines for Training Programs](#). Applicants are encouraged to demonstrate the use of [Gender and Sex-Based Analysis](#) in applications.

Allowable Costs

The awards consist of a stipend.

Conditions of Funding

All conditions specified in [CIHR General Grants and Awards Policies](#) shall apply to applications funded through this funding opportunity. Conditions cover areas such as Applicant and Institutional Responsibilities, Ethics, Official languages policy, Access to Information and Privacy Acts, and Acknowledgement of CIHR's Support. Successful applicants will be informed of any special financial conditions prior to the release of funds or when they receive CIHR's Authorization for Funding (AFF) document.

Access to Information Act and Privacy Act, and the Personal Information Protection and Electronic Documents Act (PIPEDA)

All personal information collected by CIHR about applicants is used to review applications, to recruit reviewers, to administer and monitor grants and awards, to compile statistics, and to promote and support health research in Canada. Consistent with these purposes, applicants should also expect that information collected by CIHR may be shared as described in [Use and Disclosure of Personal Information Provided to CIHR for Peer Review](#).

CIHR as a federal entity is subject to the *Access to Information Act* and the *Privacy Act*, therefore the requirements of these two statutes will apply to all information located in CIHR's premises including, without limitation, cost-sharing agreements related to this funding opportunity and all matters pertaining thereto.

While respecting the application of the *Privacy Act* to federal entities, all signing parties involved in a collaborative agreement will also be bound by the *Personal Information Protection and Electronic Documents Act* (PIPEDA). All personal information (as identified by the PIPEDA) collected, used or disclosed in the course of any commercial activity under collaborative agreements related to the Funding opportunity will be collected, used and disclosed in compliance with the PIPEDA.

Communication Requirements

Grant recipients are required to acknowledge CIHR, its institutes and partners in any communication or publication related to the project. See CIHR General Grants and Awards Policies, Public Communication and Acknowledgement of CIHR's Support for details on CIHR's communication requirements. The contributing institutes/partners will be identified on the Authorization for Funding and decision letter.

Performance Measurement

CIHR is committed to demonstrating results to Canadians for the money invested in health research. Therefore, processes for monitoring progress and appropriate use of funds, as well as for performance measurement and program evaluation are in place. As a result, funding recipients must:

- contribute to the monitoring, review and evaluation of CIHR's programs, policies and processes by participating in evaluation studies, surveys, workshops, audits and providing data or reports as required for the purpose of collecting information to assess progress and results; and
- encourage their associates, trainees and administration to participate in the monitoring, review and evaluation of CIHR's programs, policies and processes as required.

Review Process and Evaluation

Peer Review

A CIHR peer review committee will evaluate the full applications. The committee may be drawn from one of CIHR's pre-existing committees or may be created specifically for this funding opportunity. Committee members are selected based on suggestions from many sources including the institute(s)/portfolio(s) and partner(s), following CIHR's Policy on Confidentiality, Conflict of Interest and Privacy Issues in Peer and Relevance Review (CCIP).

Evaluation Criteria

Master's Awards are reviewed in accordance with the Guide for Reviewers - CIHR Master's Award.

The following general criteria for evaluating training award applications will be used:

- Achievements and activities of the candidate.
- Characteristics and abilities of the candidate.
- Research training environment.

Note: This funding opportunity requires the use of CIHR Web Forms to apply for funding.

- **Reminder to applicants:** Please ensure that your application is complete (including all required signatures) and submitted on time to CIHR. Effective September 1, 2008, CIHR will assume no responsibility in following-up with applicants who submit an incomplete application. Incomplete or late applications will not be accepted into the competition.

Additional instructions to be followed for this funding opportunity:

Full applications for both direct applicants and those applying through a Canadian institution must be courier stamped by this date. **Canadian institutions accepting applications will set their own application deadline.**

How is the candidate applying?

1. Through the Canadian institution at which the candidate will be registered* during the Fall semester prior to the CIHR deadline.

(*That is, registered in any level course, or in any other capacity; for example, part-time, full-time, one course only, course not related to the master's program, or special student.)

Deadlines are set by the university; please contact them for deadlines, as a pre-selection process may be held at the university level. CIHR will provide each eligible Canadian institution an allocated number of submissions allowed by that institution.

Institutions must forward their applications to CIHR no later than **February 1st** for them to be considered in the competition.

2. Directly to CIHR, for candidates who will not be registered at a Canadian institution during the Fall semester prior to the CIHR deadline.

Applications must be sent to CIHR no later than **February 1st**.

A complete application consists of:

- CIHR Training Module (pages 1, 3, 4, 5, 7, 8, 10, Acknowledgement Page and Consent Form).
- Common CV module (validated for CIHR) for the candidate only (**Draft copies will not be accepted**).
- Original official transcripts (must be an unopened original from the issuing institution; it is recognized that for applications submitted through a university, university officials will have opened the transcript envelopes before they reach CIHR). Certified true copies will only be accepted from institutions outside North America.
- CIHR Sponsors' Report on a Candidate for a Canada Graduate Scholarships (CGS) Master's Award [[PDF \(fillable\)](#) | [PDF](#) | [Help](#)] to be completed by two sponsors who have had an opportunity to assess the candidate's potential - one of these should be the candidate's most recent research supervisor, if applicable.
- Confirmation of Canadian citizenship or residency (permanent residents only).

Only the original application and attachments are required.

Responsibilities of Reviewers

- Avoid conflict of interest;
- Respect the confidentiality of applications;
- Review and rate each assigned application using the criteria provided by CIHR;
- Submit reviews and ratings to CIHR via ResearchNet by the deadline specified; and
- Provide a re-review if requested by CIHR.

Avoid Conflict of Interest

- As soon as you receive the applications to be reviewed, look over the candidates' names, the names of their proposed supervisors and their institutions, and indicate using ResearchNet your ability to review each application that has been assigned to you.

You must not be involved in the review if the applicant or the proposed research supervisor:

- **Is from your institution** (unless they are located in another campus);
- **Has collaborated with you** within the last five years;
- **Has been supervised by you** within the last ten years;
- **Is a close personal friend or relative;**
- **Has major differences of opinion with you;**
- **If you could be affected financially** from the outcome of the application; or

- Are for some other reason unable to provide an objective review.

If you would be in conflict of interest, or might be perceived to be in conflict of interest, notify CIHR immediately (via ResearchNet) and the application will be assigned to another reviewer.

Respect the Confidentiality of Applications

Do not forward copies of applications or discuss them with others.

Reviewing the Assigned Applications

Read the Applications

Read all of your assigned applications before rating any of them. As you examine each application, jot down notes to capture your impressions. Please do not forward copies (paper or electronic) of these notes to CIHR.

Be alert to unconscious bias related to gender, discipline or geographic location. Remember that:

- Career interruptions for child bearing and raising can influence opportunity for knowledge production, publications and related variables;
- Different disciplines and environments offer different opportunity for publication; and,
- The reputation of institutions should not affect your view of applicants or their research training environment.

You are free to consult published lists of journal impact factors when assessing the candidate's research accomplishments. Note however that journal impact factors vary from one discipline to another and that they do not necessarily indicate the quality of individual articles.

Rate the Applications

Examine each application in detail and rate it against each of the three criteria described in [Annex 1](#). Use the rating scales and notes to reviewers described in [Annex 2](#) to help in determining an appropriate rating for each criterion.

Please note that only applications rated 3.5 or higher are eligible for CIHR funding. The range 3.0 to 3.4 should be used for applications which, while rated as good, are not considered to be a high priority for CIHR funding. Please note that applications rated 3.0 to 3.4 are not eligible for CIHR funds, including those from partnership programs.

Reviews and ratings for CIHR Master's Award applications are submitted to CIHR via ResearchNet. The electronic rating forms are available to reviewers when they access ResearchNet.

Provide Other Information for CIHR and Feedback to Applicants

Length of Term: If you think that the proposed duration for the master's award is too long or too short, indicate the length that you recommend.

Human Stem Cell Research: Indicate if the candidate's research involves human stem cells.

Other Comments for CIHR: Mention any ethical issues, et cetera.

Feedback for the Applicant: Prepare brief comments on the application for transmittal to the candidate by CIHR via ResearchNet after the competition. Carefully avoid language that might be construed as sarcastic, flippant, arrogant, or inappropriate in any way. Cover both strengths and weaknesses, particularly those that could be realistically addressed by the applicant.

Send Reviews and Rating to CIHR via ResearchNet

Please respect the deadline provided by CIHR by submitting your reviews and ratings via ResearchNet by the date specified via correspondence with CIHR staff responsible for the Master's Awards program.

Be Prepared for a Re-Review Request from CIHR

When all scores are received, CIHR will calculate an average for each application. CIHR will then identify applications which are at risk of an unfair decision because of a wide spread between the two reviewers' ratings. In such cases, CIHR will ask both reviewers to reconsider their initial assessment and resubmit scores. Usually this second review will reduce the gap between scores to an acceptable size. If it does not, CIHR will obtain a third review.

Just in case you are asked to do a re-review, keep the applications and your working notes on file until competition results have been announced.
