PURPOSE:

The purpose of the University of Manitoba Bursary program is to provide financial assistance to students who demonstrate financial need. Bursaries are intended to assist with living costs; they are not intended to provide full funding for the school year. Submitting an application does not guarantee that you will receive a bursary.

ELIGIBILITY AND OTHER CONSIDERATIONS

- You must demonstrate a realistic financial need to be considered for a bursary and each application must be completed as accurately as possible.
- An excessive deficit/need submitted on this form will not result in a greater bursary amount and may disqualify you.
 - o If your deficit amount exceeds \$5000, please speak to the Financial Aid & Awards staff before submitting your application.
- You must be registered in both terms (Fall & Winter), although you may be a full-time or parttime student. If you are not registered for classes in both terms when your application is reviewed and processed, you will not be considered eligible.
- You must have at least **70% high school average** (1st year students) or a minimum **2.0 GPA** (returning UM students) to qualify.
- If you are receiving a government student loan, attach a complete copy of your Notice of Assessment (MB Students) or Need Assessment (other provinces).
 - o If you attach this, **do not** fill out the Expenses/Resources Budget on page one.
- If you receive a bursary, you will be mailed notification in late December, so be sure to update your address on Aurora Student.
