**Assistant Professor of Bioresource Management

The School of Environmental Sciences (Ridgetown Campus) of the University of Guelph invites applications from outstanding candidates for a full-time, non-tenure tracked, Assistant Professor specializing in the area of bioresource management. This is a contractually limited position for a period of five years. Start date is negotiable, preferably not later than 1 September 2011. The successful candidate must hold a Ph.D., and demonstrate potential to secure research funding, teach at an undergraduate and diploma level, and engage key stakeholders in extension activities. Applications are invited from any area of bioresource management, including, but not limited to: water resource management (hydrology, water quality); post harvest technology (biomass conversion); bioenergy; waste management; or environmental protection.

The successful applicant will engage in: research (20%); service (20%); degree and diploma program teaching, and supervising graduate students (60%). They will be expected to develop and lead an active research program that focuses on developing a sustainable rural economy. The position liaises with a broad cross section of stakeholders, which may include technology providers, agricultural producers, rural municipalities, the food and feed industry, utility companies, and the emerging bioeconomy. Applicants should be able to teach courses in some or all of these areas: environmental science, agricultural resource management and wastewater treatment

The position resides at the Ridgetown Campus of the University of Guelph - 200 km southwest of Guelph, in the heart of one of the most productive and diverse agricultural regions of Canada. The campus has recognized strengths in applied agriculture, economics, bio-resource, and environmental sciences.
