The SSHRC application forms and guides for the academic year 2010/2011 are available on their website at https://webapps.nserc.ca/SSHRC/faces/logonFellowships.jsp?lang=en_CA . Application forms are available in an on-line version only. Students must register in order to log in and complete the application form and may save their work and review it periodically before printing the completed application form.

I am attaching the ranking sheets as well as additional information from SSHRC for your convenience.

SSHRC's deadline for receipt of applications from all universities is January 15, 2010 for the Doctoral applications and February 2, 2010 for CGS Master's applications. Departments are responsible for collecting, assessing, and ranking completed applications by their own deadline and forwarding them to the **Faculty of Graduate Studies by Thursday, November 5, 2009**. This will allow the University Awards Committee time to assess recommended applications, select the top students to fill our quota, and explore ways in which these applications could be strengthened.

Please note that there is a separate allocation of business related applications for the SSHRC CGSM competition. Please indicate on the ranking sheet whether you think the application may be eligible for the business related allocation.

Please ensure that all applications submitted are complete and that the applicant is eligible to apply for the award. Note that incomplete applications will be considered ineligible and returned to the Department. If you have any questions, please contact me.

**PROGRAM CHANGES AND IMPORTANT REMINDERS
FOR THE 2010-2011 JOSEPH-ARMAND BOMBARDIER CGS-MASTER'S COMPETITION**

Number of Awards (Change)

We are once again able to offer 1,300 Joseph-Armand Bombardier CGS-Master's awards this year. In addition, we are able to offer 200 Joseph-Armand Bombardier CGS-Master's awards for business-related applications for this competition year. Universities will continue to be asked to submit alternate applications to replace potential declines, however, this number will now be proportionate to the university's regular allocation. Please note however, that the number of alternate business-related applicants will be unlimited provided applications meet the eligibility and selection criteria for an award.

Eligibility to Apply (New)

Applicants registered in a **degree program** at a university with an allocation at the time of application, must apply through their university. If they are not currently registered, but completed their previous degree in 2009, they must apply through the university that awarded their last degree, provided that university has an allocation. Applicants registered concurrently at a Canadian university and a foreign university must apply through the Canadian university, if that university has an allocation. All other applicants must apply directly to SSHRC by December 14, 2009.

Eligibility of Subject Matter at SSHRC (New)

As a result of the recent government-mandated Strategic Review, research that is eligible for funding under the mandate of CIHR is no longer eligible for consideration at SSHRC. This includes research that is primarily intended to improve health, produce more effective health services and products and/or strengthen the Canadian health care system (e.g., research concerning the treatment, prevention or diagnosis of a condition, the evaluation of the effectiveness of health programs, the development of health management systems, etc.).

If the research proposal is related to health or in psychology, applicants must justify the submission of their proposal to SSHRC (rather than to NSERC or CIHR), based on the newly published Guidelines for the Eligibility of Subject Matter at SSHRC (www.sshrc-crsh.gc.ca/site/apply-demande/background-renseignements/selecting_agency-choisir_organisme_subventionnaire-eng.aspx)

Combined MA/PhD Programs (New)

Students who are or will be registered in the first or second year of the Master's portion of a combined MA/PhD program may apply to the CGS Master's program provided they have not completed more than 12 months of graduate-level study at the time of taking up the award.

Students, who are currently registered in a combined MA/PhD program and have or will have completed more than 12 months of graduate level study at the proposed start date of the award, can only apply to the Doctoral Awards program.

Program Eligibility (Change)

The first bullet has been expanded to include programs that may result in the production of a publication, performance, recital or exhibit. The third bullet now also includes acquiring

knowledge and experience sufficient to **conduct**, assess and interpret research and scholarship in the field. The new text reads as follows:

The scholarship is tenable only in degree programs that include significant research training. Research training normally involves:

- demonstrating the ability to conduct original research by the completion of a scholarly thesis, major scholarly paper, **project, publication, performance, recital, or exhibit**; and/or
- completing course work in research methods and/or statistics appropriate for the discipline or field of study; and/or
- acquiring knowledge and experience sufficient to **conduct**, assess, and interpret research and scholarship in the field.

Research Contributions (New)

Applicants may append one additional page.

Bibliography and Citations (Change)

The page limit has been reduced to a maximum of five pages.

Combined Undergraduate and Graduate Degree Programs (Reminder)

As SSHRC does not currently support studies at the undergraduate level, the Joseph-Armand Bombardier CGS-Master's program will not fund degree programs that combine undergraduate and graduate degrees.

First-Class Average (Reminder)

If you submit, as part of your A-List allocation, an application for a student who did not achieve a first-class average in each of the past two years of full-time study (or equivalent), it is very important that the Departmental Appraisal provide a clear justification why you nevertheless forward the application. This should include an explanation of why you judge this to be a meritorious application, not merely a mention of the lack of a first-class average. For the purpose of meeting the eligibility criteria of the program, please ensure that the averages cited in the Departmental Appraisals are expressed in the same way as the standard first-class average your university specified in Appendix E. For example, if the first-class average is a percentage, the averages shown on the Departmental Appraisal should also be percentages.

Please also be sure to specify one standard first-class average for your university, regardless of the faculty or the department. For example, there cannot be a different first-class average for the Department of English and the Department of Sociology.

Number of Months of Graduate Studies (Reminder)

Applicants must indicate the number of months of graduate studies they will have completed at the expected start date of the award. They must include all previous studies at the graduate level, regardless of discipline.

SSHRC assumes that all studies were full-time and uninterrupted (i.e., beginning of September 2008 to end of August 2009 means 12 months of study). Students who studied on a part-time basis, or who interrupted or intend to interrupt their studies with their university's official approval, must specify the dates of interruption or part-time study in their Program of Study. They may take these periods into account when calculating the number of months of study completed. SSHRC may contact the university to verify the information provided.

Official Transcripts (Reminder)

SSHRC will accept official transcripts only. Applicants must include all undergraduate and graduate-level transcripts.

If an applicant studied at a university which does not provide transcripts, they must include an official certificate of success which outlines the program in which they were registered, the date of initial registration, and the degree obtained or sought.

Students should be aware that documents sent to SSHRC in support of their application cannot be returned to them.

Program of Study (Change)

Applicants must clearly outline the research training component of the degree program and explain how their program of study meets one or more of the three components listed under Program Eligibility. This must now also be identified in the application profile section of the application.

Program of Study - Degrees without a Thesis (Reminder)

If the degree program does not involve a thesis, major research paper/essay, or major research project, applicants must remember to clearly outline the research training component of the degree in their Program of Study.

Program of Study - Degrees in Fine Arts (Reminder)

If the output of the degree program is an artistic creation, rather than a thesis, applicants must clearly outline the research component of their proposed work in their Program of Study. They should indicate the objectives of their research, the context, methodology, and contribution to the advancement of knowledge.

Alternate List (Change)

Universities will continue to be asked to submit alternate applications to replace potential award declines, however, this number will now be proportionate to the university's regular allocation (pls. see allocation table). Please note however, that the number of alternate business-related applicants will be unlimited, provided applications meet the eligibility and selection criteria for an award.

Please forward a complete application for each alternate candidate.

**ROLES AND RESPONSIBILITIES OF UNIVERSITY ADMINISTRATORS
IN THE ADMINISTRATION OF
THE JOSEPH-ARMAND BOMBARDIER CANADA GRADUATE SCHOLARSHIPS - MASTER'S
COMPETITION 2010-2011**

In an effort to assist universities in obtaining consistent results with the nomination process, we ask that you follow the guidelines outlined below. We would appreciate your advising students of the involvement of university administrators in the process.

DEADLINE

Each university must set its internal deadline, taking into consideration SSHRC's deadline (Tuesday, February 2, 2010) and the university's own work load. The person responsible for receipt of the completed applications at the university should be named.

APPLICATION FORMS

Applicants must use the web-based application form. Applicants must sign and submit the complete application on paper.

APPOINTMENT OF UNIVERSITY SELECTION COMMITTEE(S)

Each university should establish the number of selection committees required to efficiently operationalize the selection process. Each committee should be composed of at least three members.

VERIFICATION OF APPLICATIONS

Status of applicants and where to apply

Applicants registered in a degree program at a university with an allocation at the time of application, must apply through their university. If they are not currently registered, but completed their previous degree in 2009, they must apply through the university that awarded their last degree, provided that university has an allocation. Applicants registered concurrently at a Canadian university and a foreign university must apply through the Canadian university, if that university has a CGS allocation. All other applicants must apply directly to SSHRC by December 14, 2009.

Completeness, eligibility, and quality of applications

Applications should be verified for completeness, legibility of documentation and for eligibility of the applicants and their proposed research. Please ensure that the research proposal falls under SSHRC's mandate. The newly published guidelines for subject eligibility at SSHRC can be found on our website at www.sshrc-crsh.gc.ca/site/apply-demande/background-renseignements/selecting_agency-choisir_organisme_subventionnaire-eng.aspx. If in doubt, please consult SSHRC staff.

Only applications with duly completed programs of study should be forwarded to SSHRC for consideration. Incomplete or ineligible applications will not be accepted.

Business-related applications

As noted in the "program changes" document, some universities may also qualify for an additional allocation for a limited number of CGS Master's awards for business-related applications for the 2010-2011 competition. Applicants who wish to be considered for a CGS

Master's scholarship for business-related research must ensure their proposed research has a broad focus on business.

SSHRC's responsibility is the administration of these additional scholarships in keeping with its mandate to support excellence in research and research training in the social sciences and humanities. In this regard, the Council uses a broad definition of business-related. Examples of such business-related research could include:

- the role of business historians;
- philosophers focused on business ethics;
- political scientists focused on regulatory frameworks;
- economists focused on stimulus strategies;
- management researchers focused on corporate operations;
- sociologists focused on labour markets;
- literary scholars focused on the new digital economy; and
- musicologists focused on the creative industries

If in doubt about the eligibility of a proposed program of study, please contact SSHRC staff.

REVIEW OF APPLICATIONS BY UNIVERSITY SELECTION COMMITTEE(S)

Applications must be assessed according to the specific criteria described in the enclosed document entitled "Guidelines for University Selection Committee(s)" (see Appendix A). The purpose of the review is to identify applicants who are nominated for a Joseph-Armand Bombardier CGS-Master's award, to identify applicants to serve as alternate award holders in the event of declined awards, and to identify candidates who are not nominated.

TRANSCRIPTS

Applicants must include official undergraduate and graduate transcripts with their application.

This will facilitate the vetting process at SSHRC and the evaluation by the selection committee of any contentious cases.

ANNOUNCEMENT OF FINAL RESULTS

Once SSHRC has completed its selection process, each university will receive three lists: the first indicating the results for all candidates that the university nominated, the second indicating the list of successful candidates who had indicated the intent to take up the award at the university, and the third a complete list of all successful applicants in the competition.

Furthermore, SSHRC will send individual results to each candidate by mail. However, the Faculty of Graduate Studies may release the results to candidates whose applications were submitted by the university.

GUIDELINES FOR THE UNIVERSITY SELECTION COMMITTEE(S)

The following criteria must be used by the University Selection Committee(s) for the purpose of determining eligibility of candidates and programs and for evaluating candidates in the nomination process.

Applicant Eligibility

Eligibility to Apply for an Award

To qualify to apply to this program, the candidate must:

- be a citizen or permanent resident of Canada;
- be applying for support to pursue a first graduate degree (i.e., master's or equivalent) and not have completed more than 12 months of full-time graduate study at the proposed start date of the award: all previous studies at the graduate level, regardless of discipline, will be included in determining eligibility;
- have achieved a first-class average, as determined by the university, in each of the last two years of full-time study or equivalent;
- not have already received an award for master's-level study from SSHRC, NSERC or CIHR;
- not be applying for graduate funding in the 2009-10 academic year to NSERC or CIHR;
- not be pursuing a degree program that combines undergraduate and graduate studies, and
- if indicating interest in a J.-Armand Bombardier CGS Master's award for business-related research, be pursuing research with a broad focus on business.

Combined MA/PhD Programs

- If an applicant is or will be registered in a combined MA/PhD program, they may apply to the Joseph-Armand Bombardier CGS Master's program for the first or second year of the master's portion of the combined program, provided they have not exceeded 12 months of graduate level study at the time of the proposed start date of the award.
- If they are currently registered in a combined MA/PhD program and have or will have completed more than 12 months of graduate level study at the proposed start date of the award, they may only apply to the Doctoral Awards program.

If the applicant completed the bachelor's degree before January 1, 2005 (date all degree requirements were completed, not date of graduation) and has not been registered at a university since that date, the candidate is not eligible to apply to this program.

Eligibility to Hold an Award

At the time of taking up the award, the candidate must:

- be registered full-time, at a recognized Canadian university, in the first year of a master's or combined MA/PhD program in the social sciences or humanities that includes advanced research training (as defined in Program Eligibility below);
- or
- be registered full-time, at a recognized Canadian university, in a master's or combined MA/PhD program in the social sciences or humanities that includes advanced research

training (as defined in Program Eligibility below), and have completed no more than 12 months of full-time study or equivalent at the graduate level.

and

- have completed all requirements for the bachelor’s degree.

Notes:

A qualifying or "make-up" year of study is not eligible for support.

Joseph-Armand Bombardier CGS-Master’s Scholarships are available to those who are registered part-time because of a disability. For this purpose, disability is defined as “a functional limitation resulting from a physical, sensory, or mental impairment, which, for an indefinite period, affects the ability of the student to perform the activities necessary to participate fully in his or her learning.”

Federal government employees are eligible to hold an award only if on an unpaid leave of absence (no salary or special allowances permitted).

Program Eligibility

The scholarship is tenable only in degree programs that include significant research training. Research training normally involves:

- demonstrating the ability to conduct original research by the completion of a scholarly thesis, major scholarly paper, project, publication, performance, recital, or exhibit; and/or
- completing course work in research methods and/or statistics appropriate for the discipline or field of study; and/or
- acquiring knowledge and experience sufficient to conduct, assess, and interpret research and scholarship in the field.

Evaluation Criteria

The following table shows the three weighted evaluation criteria:

<p>Academic Excellence Weighting: 60%</p>	<p>Academic excellence—as demonstrated by academic transcripts, awards and distinctions.</p>
<p>Research Potential Weighting: 30%</p>	<p>Quality of analytical skills, ability to think critically, ability to apply skills and knowledge, judgement, originality, initiative and autonomy, determination and ability to complete projects within an appropriate period of time—as demonstrated in the description of program of study and by work experience, research contributions, letters of appraisal, and, if applicable, the departmental appraisal.</p>
<p>Communication Skills Weighting: 10%</p>	<p>As demonstrated in the description of the program of study and, if relevant, by work experience, community involvement and other extracurricular activities, as well as by letters of appraisal, the quality of presentation of the application and, if applicable, the departmental appraisal.</p>

APPEALS PROCEDURES

Only those appeals based on the grounds that there has been a procedural or administrative error in the adjudication process should be considered. For example, an applicant might contend that certain documentation was lost or not considered in the evaluation of a proposal and that the application had therefore not been considered fairly in competition with all others. Complaints based on a lack of due process should be investigated by an official of the Faculty of Graduate Studies.

Because of the competitive nature of the selection process, universities must not consider appeals based upon disagreement with the academic judgment of a University Selection Committee, including its interpretation of assessments or its evaluation of a proposal.

SSHRC will reroute letters complaining about a university's decision to the appropriate university administrator.

Calculation of Allocation

SSHRC will award a total of 1300 Joseph-Armand Bombardier CGS Master's awards in the 2010-2011 competition. Canadian universities will nominate a total of 1260 candidates while SSHRC has reserved 40 awards for eligible candidates who must apply directly to SSHRC. These include candidates who are students at a university that did not receive an allocation, candidates currently studying at foreign universities or candidates not registered in a degree program at a Canadian university in 2009.

In addition, eligible universities may forward a total of 194 candidates who wish to be considered for business-related awards. Six business-related awards have been reserved for direct applicants.

The attached list contains only names of universities with an allocation of one or more nominations for the Joseph-Armand Bombardier Canada Graduate Scholarships.

Allocations are calculated based on the number of bachelor's degrees in the social sciences and humanities each university conferred in 2006* and on the number of full-time master's students in the social sciences and humanities registered in the 2006-2007 academic year.

Universities that conferred less than 50 bachelor degrees in 2006, did not qualify for an allocation.

1: PROGRAM CHANGES AND IMPORTANT REMINDERS FOR THE 2010-2011 SSHRC DOCTORAL AWARDS PROGRAM COMPETITION

Eligibility to Apply (New)

Applicants registered in a degree program at a Canadian university with a quota, must apply through the university. Applicants registered concurrently at a Canadian university and a foreign university must apply through the Canadian university, if that university has a quota. All other applicants apply directly to SSHRC.

Eligibility of Subject Matter at SSHRC (New)

As a result of the recent government-mandated 2008 *Strategic Review*, research that is eligible for funding under the mandate of CIHR is no longer eligible for consideration at SSHRC. This includes research that is primarily intended to improve health, produce more effective health services and products and/or strengthen the Canadian health care system (e.g., research concerning the treatment, prevention or diagnosis of a condition, the evaluation of the effectiveness of health programs, the development of health management systems, etc.).

If the research proposal is related to health or in psychology, applicants must justify the submission of their proposal to SSHRC (rather than to NSERC or CIHR), based on the newly published *Guidelines for the Eligibility of Subject Matter at SSHRC*, which are available at http://www.sshrc-crsh.gc.ca/site/apply-demande/background-renseignements/selecting_agency-choisir_organisme_subventionnaire-eng.aspx.

Program Eligibility (New)

SSHRC has created a program eligibility provision in the description of the Doctoral Awards program which focuses on promoting and supporting "research training" (not type of degree). The new text reads as follows:

Doctoral Awards are tenable only in degree programs that include significant original, autonomous research that leads to the completion of a dissertation, major scholarly publication, performance, recital, or exhibit, which is peer-reviewed at the institutional level.

Combined MA/PhD Programs (New)

Students who are or will be registered in the first or second year of the master's portion of a combined MA/PhD program may apply to the CGS Master's program provided they have not completed more than 12 months of graduate-level study at the time of taking up the award.

Students, who are currently registered in a combined MA/PhD program and have or will have completed more than 12 months of graduate level study at the proposed start date of the award, can only apply to the Doctoral Awards program.

Calculation of the Number of Months of Doctoral Study Completed (Change)

In calculating the value and duration of awards, SSHRC includes all prior doctoral-level studies in the same discipline. This also applies to students who have been accelerated from a master's program into a doctoral program without obtaining the Master's degree. In the case of students who are applying for, or registered in, a combined MA/PhD program, SSHRC will not include the first 12 months of the combined program in the calculation of the value and duration of Doctoral Awards. These procedures apply whether or not the degree was

completed and whether or not the current university recognizes the previous credits or years of study.

Official Letter Confirming Part-time Studies and/or Leave of Absence (New)

Students who studied on a part-time basis, or who interrupted their studies with their university's official approval, must specify the dates of interruption or part-time study as documented in an official letter from their university.

Change to Guidelines Relating to Multiple Applications (New)

In general, applicants may submit only one application to SSHRC in a given year. Also, fellowship and scholarship applicants may only submit one application in each academic year to either SSHRC or NSERC or CIHR. The only exception to this rule is that applicants may simultaneously apply to both the Doctoral Awards program and the Vanier CGS Doctoral Nominations program. In addition, successful applicants may not receive awards from two or more fellowships and scholarships programs.

Bibliography and Citations (Change)

The page limit has been reduced to a maximum of 5 pages.

Program of Study - Degrees in Fine Arts (Reminder)

If the output of the degree program is an artistic creation, rather than a thesis, applicants must outline clearly the research component of their proposed work in their Program of Study. They should indicate the objectives of their research, the context, methodology, and contribution to the advancement of knowledge.

Combined Undergraduate and Graduate Degree Programs (Reminder)

As SSHRC does not currently support studies at the undergraduate level, the Doctoral Awards program will not fund degree programs that combine undergraduate and graduate degrees.

Official Transcripts (Reminder)

SSHRC will accept official transcripts only. Applicants must include all undergraduate and graduate-level transcripts.

If an applicant studied at a university which does not provide transcripts, they must include an official certificate of success which outlines the program in which they were registered, the date of initial registration and the degree obtained or sought.

Students should be aware that documents sent to SSHRC in support of their application cannot be returned to them.

2: ROLES AND RESPONSIBILITIES OF FACULTIES OF GRADUATE STUDIES IN THE CO-MANAGEMENT OF THE 2010-2011 DOCTORAL AWARDS PROGRAM COMPETITION

In an effort to assist universities with the pre-selection process, we are seeking your collaboration in following the guidelines outlined below. We would appreciate your advising students of the involvement of university administrators in the process.

DEADLINE

Each university must set its internal deadline taking into consideration SSHRC's deadline for submitting applications, which is **Friday, January 15, 2010**.

APPOINTMENT OF UNIVERSITY SELECTION COMMITTEE(S)

Each university should establish the number of selection committees required to efficiently operationalize the selection process. Each committee should be composed of at least three members.

VERIFICATION OF APPLICATIONS

Status of applicants and where to apply

Applicants registered in a degree program at a Canadian university with a quota, must apply through the university. In addition, applicants registered concurrently in a degree program at a Canadian university with a quota and a foreign university must apply through the Canadian university.

Completeness, eligibility, and quality of applications

Applications should be verified for completeness, legibility of documentation and for eligibility of the applicants and their proposed research. Please ensure that the research proposal falls under SSHRC's mandate. The newly published guidelines for subject eligibility at SSHRC can be found on our website at www.sshrc-crsh.gc.ca/site/apply-demande/background-reseignements/selecting_agency-choisir_organisme_subventionnaire-eng.aspx. If in doubt, please consult SSHRC staff.

Incomplete or ineligible applications will not be accepted by SSHRC.

Multiple applications

Please note that in any given academic year, in general, applicants may submit only one application to SSHRC. Also, fellowship and scholarship applicants may only submit one application in each academic year to either SSHRC or NSERC or CIHR. The only exception to this rule is that applicants may simultaneously apply to both the Doctoral Awards program and the Vanier CGS Doctoral Nominations program. In addition, successful applicants may not receive awards from two or more fellowships and scholarships programs.

REVIEW OF APPLICATIONS BY UNIVERSITY SELECTION COMMITTEE(S)

Applications must be assessed according to the specific criteria described in the enclosed document entitled "Guidelines for University Selection Committee(s)" (see **Appendix A**). The purpose of the review is to identify applications which are recommended to SSHRC for the

National Competition and to identify applications which are not recommended. We are also enclosing a copy of the marking scheme used at SSHRC, as well as an assessment form that may be useful for committee members (see **Appendices B and C**).

GUIDELINES FOR THE UNIVERSITY SELECTION COMMITTEE(S)

The following selection criteria are used by the SSHRC's adjudication committees and must be used by the University Selection Committee(s) in evaluating candidates.

Selection committees evaluate applicants solely on academic merit, measured by:

- past academic results, demonstrated by transcripts, awards and distinctions;
- the program of study and research and its potential contribution to the advancement of knowledge;
- relevant professional and academic experience, including research training, as demonstrated by conference presentations and scholarly publications;
- two written evaluations from referees; and
- the departmental appraisal (for those registered at Canadian universities).

The University Selection Committee(s) should not assign particular weights to the above criteria, but should take each into consideration when evaluating the candidates. However, in applying the evaluation criteria, it is appropriate to take into account the individual applicant's stage in his or her academic program.

While Committee members are expected to take into account the year of study in order to fairly evaluate candidates at different stages of their academic programs, the year of study is not in itself a criterion to be evaluated.

Although candidates have been asked to justify their choice of university, the proposed location of tenure is not a factor in the selection process.

Universities may use their own marking scheme or adopt SSHRC's model with its own committees; please find enclosed the guidelines which are sent to our selection committee members (Appendix B).

MARKING SCHEME USED BY SSHRC SELECTION COMMITTEES

To facilitate the ranking of all applicants in the fellowships competitions, the Council has developed a 100-point and a 10-point scale for marking applications. Large universities may wish to use the 100-point scale to facilitate the ranking of applications, while small universities may prefer the 10-point scale. Using this scale, the marks must be distributed according to the proportions specified in the columns below. Marks should not be interpreted as absolute values, but rather as measures of standing, relative to the other candidates in the competition.

For the system to work properly, it is imperative for members to rigorously apply this distribution formula.

Score 10 - point scale	Score 100 - point scale	% of applications to be assigned the score
10 (highest score)	90 - 100 (highest mark)	2%
9	80 - 89.9	5%
8	70 - 79.9	10%
7	60 - 69.9	14%
6	50 - 59.9	19%
5	40 - 49.9	19%
4	30 - 39.9	14%
3	20 - 29.9	10%
2	10 - 19.9	5%
1 (lowest score)	1 - 9.9 (lowest score)	2%

The recommended procedure to generate the desired distribution is:

For each application, fill out the assessment form provided and allocate a mark (from 1 to 100 or from 1 to 10). You should provide enough detail on the assessment form for easy reference when reviewing your marks. (Please see Appendix C for a copy of the assessment form used by SSHRC).

Sort the assessment forms into groups according to the mark you have given. That is, put all the 90 to 100's (or the 10's) in one group, all the 80 to 89.9 (or the 9's) in another, etc.

Review your initial distribution, beginning with the applications marked at the top. If the applications in this group exceed the allowed number, rank them on the basis of your comments on the assessment sheets. Keep the required number in the top category and add the ones at the bottom of the list to the next group. If you have too few in the top category, proceed to the next category and rank them. Place the highest scoring application(s) from this group in the top category until the desired number is reached.

If the above procedure is followed for each category, at the end of this process the marks should be distributed as required. This procedure will ensure that, when combined, the marks of the committee members will make possible a final listing of recommended candidates.

APPEALS PROCEDURES

Only those appeals based on the grounds that there has been a procedural or administrative error in the adjudication process should be considered. For example, an applicant might contend that certain documentation was lost or not considered in the evaluation of a proposal and that the application had therefore not been considered fairly in competition with all others. Complaints based on a lack of due process should be investigated by an official of the Faculty of Graduate Studies.

Because of the competitive nature of the selection process, universities must not consider appeals based upon disagreement with the academic judgment of a University Selection Committee, including its interpretation of assessments or its evaluation of a proposal.

SSHRC will reroute letters complaining about a university's decision to the appropriate university administrator.
